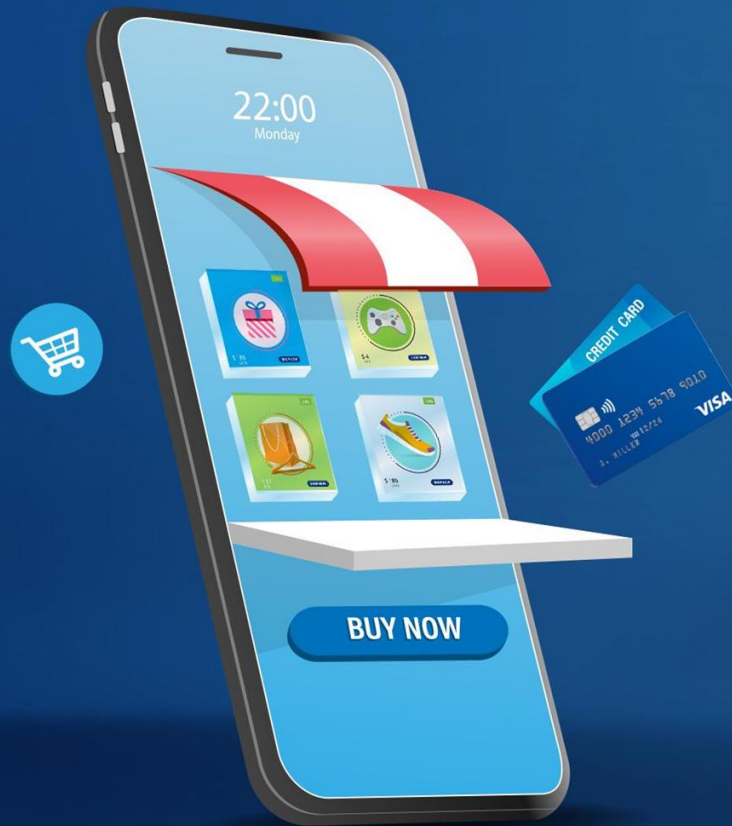

HSBC and Visa Mauritius E-Commerce Campaign Terms and Conditions

1. Overview of the Campaign

HSBC Visa credit cardholders can win Rs.500 cash back for any online payment made worth a minimum of 125 US dollars equivalent to Rs.5,000 or more. Both online local and international transactions are valid for this Campaign.

2. Disclaimer

- This Campaign is operated by The Hongkong and Shanghai Banking Corporation Limited that issued the HSBC Visa Credit Card to its cardholders and not by Visa.
- The campaign is financed by Visa. Note that Visa is not a card issuer and does not provide credit, debit or any financial services.
- Any issues with respect to the HSBC credit card should be directed to HSBC and not to Visa. The relationship between Visa and HSBC does not create any relationship direct or indirect between the cardholder and Visa. These terms and conditions are different from the agreements between you and HSBC and unless as otherwise specified in these Terms and Conditions, none of the terms of any agreement between you and HSBC has any effect on, or relationship with these Terms and Conditions.
- All brand names and logos are property of respective owners and are used for identification purposes only.

3. Duration

- The cash back is only available to HSBC Visa credit cardholders who make any payment worth a minimum of 125 US dollars equivalent to Rs.5,000 or more—the “Qualifying Transaction”), from 20 February till 8 March 2021, both dates inclusive (the “Duration”) on a first come first serve basis. Any transactions made outside this period will not be eligible. The Campaign will end on 8 March 2021 or before, if the budget is exhausted, whichever comes first.
- Transactions made within the Duration do not qualify for a cash back, if total budgeted number of winners is exhausted. Note that this is on a first come first serve basis.

4. The Campaign is subject to the following Terms and Conditions

- You become eligible to participate in the programme by holding an HSBC Visa Credit Card issued in Mauritius (excluding Visa Corporate cards and HSBC staff). Your participation rights and consent are tied to you being an HSBC Visa credit cardholder.
- Qualifying transactions are online excludes transactions done within Gaming and Gambling merchants category.
- Cardholder account should be active and not in arrears at the time the cash back is credited.
- The cash back shall be paid directly by HSBC onto the Visa credit card. The cardholder is not expected to take any action in this regard.
- Visa takes no responsibility for any inaccurate reporting or non-visibility of qualifying transaction either by collections only files or non-accessibility.
- HSBC will review the transactions from the system and automatically pull the details of the cardholders who shopped online with their HSBC Visa credit card. The cardholder will receive an email notification from the bank when the cash back is credited. This will be on a first come and first serve basis.
- HSBC Visa credit cardholder can get the cash back more than once.
- The cash back will be credited within two weeks after the end of the campaign.
- The exchange rate used for the cash back is: 1 US Dollar = 40 Mauritian Rupees
